## Do You Subscribe to Behavior Analysis Journals?

Practicing behavior analysts have numerous ethical and historical obligations to stay in contact with the research literature. For example, the BACB Guidelines for Responsible Conduct states that behavior analysts must base professional decisions on the literature (1.01-Reliance on Scientific Knowledge; 2.10-Treatment Efficacy) and maintain competence by making contact with the literature (1.03-Professional Development). In addition, ABAI's position statements on The Right to Effective Behavioral Treatment and The Right to Effective Education state that consumers who receive behavior-analytic therapeutic and educational services are entitled to programs that are based on empirical evidence. Many practitioners receive guidance about effective treatments

through conferences and workshops. However, there is no substitute for direct contact with the published literature.

Although maintaining access to the published literature can be difficult after university training has ended (see <u>Carr & Briggs, 2010</u>), targeted journal subscriptions are a low-effort way to stay informed about contemporary research. If you have not already done so, you might consider subscribing to Journal of Applied Behavior Analysis and Behavior Analysis in Practice. These journals are relatively inexpensive and routinely publish articles relevant to the practice of applied behavior analysis.

## **Changes to the Certificant Registry**

Please be informed that, effective immediately, the BACB Newsletter will be emailed to all certificants. Certificants may no longer opt out of receiving the newsletters because they represent the primary method for informing certificants about changes to BACB rules and standards. In addition, all certificants will now appear in the online <u>Certificant Registry</u>. With over 10,000 certificants, and with rapidly increasing inquiries from regulators, thirdparty payors, and consumers, the registry has increasingly become an important resource to the community. Despite these two changes, certificants will still have the ability to disable email contact through the registry and opt out of receiving mass emails from third parties about training, educational, job, and research opportunities. We encourage all certificants to review their Information Release settings at the <u>Certificant Gateway</u>.

## A Reminder about Continuing Education Content

The content of Type 2 continuing education (CE) events can address any aspect of behavior-analytic theory, methods, and/or practice. However, because these events are to provide continuing education and professional development for certified individuals, the content and level of instruction must go beyond what is required to become certified. Type 2 CE events should not simply cover

material from the BACB Task List and the coursework required to sit for the certification exam, because all BCBAs and BCaBAs should already have those basic competencies in their repertoires. Instruction should be presented at a level of difficulty that is appropriate for certificants who already have degrees and have completed some coursework in behavior analysis.
