

# Guidance for Those Applying for BCaBA Certification During the 2022 Transition

If you are unsure whether you will apply for BCaBA certification before or after January 1, 2022, when the new eligibility requirements go into effect, we recommend planning ahead to ensure that you meet **both** the current and new requirements. This document is provided as a resource you can use with your supervisor, advisor, and VCS Coordinator, among others, for planning purposes.

Review the <u>current and new requirements</u> carefully, and remember that if you have not met the current requirements and applied before January 1, 2022, you must meet the new requirements that go into effect as of 2022.



Specific Guidance for Those Who Are Unsure

The following sections provide targeted considerations for those who are unsure whether they will apply under the current or new requirements:

## Degree

- ▶ Applicants who completed a degree outside of the United States
- ▶ Applicants who have a bachelor's degree from an ABAl-accredited bachelor's program

#### Coursework

- ▶ Applicants who are enrolled in some or all 4th edition courses and plan to apply on or after January 1, 2022
- ► Applicants who are enrolled in some 2022 requirements courses in a VCS and plan to apply **before**January 1, 2022
- ▶ Applicants who are enrolled in a **full** VCS that meets the 2022 requirements and plan to apply **before**January 1, 2022

#### **Experience and Fieldwork**

► Trainees who are accruing experience/fieldwork hours and are unsure whether they will apply before or after 2022 or are wanting to use some of the hours toward the BCaBA requirements

#### Examination

▶ Candidates whose BCaBA applications were approved before January 1, 2022



We must receive an approvable application (i.e., application submitted, fee paid, all necessary documents received) before January 1, 2022, for it to be considered under the current BCaBA eligibility requirements.

## Degree

The BCaBA degree requirements will change minimally, but there are two differences worth noting:

- ▶ Applicants who completed a degree outside of the United States: Under the current requirements, your degree must be equivalent to a bachelor's degree earned in the US to meet the BCaBA degree requirements. Beginning in 2022, if your degree qualifies you for a graduate program in the country in which it was earned, it may meet the degree requirements. If your degree does not meet the current requirements, you must wait to apply until 2022 and meet all of the other eligibility requirements in effect at that time.
- ▶ Applicants who have a bachelor's degree from an ABAI-accredited bachelor's program: Under this new pathway, if you have a bachelor's degree from an ABAI-accredited program, you do not need to meet the 2022 coursework requirements. However, if you apply before 2022, you must demonstrate that you meet the 4th edition coursework requirements. If you plan to follow the 2022 Pathway 1 option but might apply early, meet with your VCS Coordinator to ensure that your coursework will meet the 4th edition requirements.

Not sure if your degree qualifies under the current requirements? You can request a preliminary degree evaluation before submitting a BCaBA Certification Application.

#### Coursework

The BCaBA coursework requirements will change in several ways (e.g., freestanding requirements, number of content hours, content hour categories). The following guidance and conversion tables may help during this transition:

Applicants who are enrolled in some or all 4th edition courses and plan to apply on or after January 1, 2022: Most of your coursework content hours can be applied toward the 2022 requirements (see the following table).

Next steps:

- 1. With your advisor or VCS Coordinator, identify the content hours for the courses that you have completed.
- 2. Use the following table to convert those hours to those in the 2022 requirements content areas.
- 3. Compare those hours to the 2022 coursework requirements.



On September 16, 2021, the BACB introduced an option for current BCBA-certified VCS Coordinators to review coursework and attest that all coursework requirements have been met. Speak with your VCS Coordinator to see if this option is right for you. If not, the following information can help you determine how your courses will be considered under different sets of requirements.

▶ Applicants who are enrolled in some 2022 requirements courses in a VCS and plan to apply **before**January 1, 2022: Your coursework content hours can be applied to 4th edition content hours (see the following table).

#### Next steps:

- 1. With your advisor or VCS Coordinator, identify the content hours for the courses that you have completed.
- 2. Use the following table to convert those hours to those in the 4th edition content areas.
- 3. Compare those hours to the 4th edition coursework requirements.

▶ Applicants who are enrolled in a **full VCS** that meets the 2022 requirements and plan to apply **before**January 1, 2022: You should meet both the 4th edition and 2022 requirements. However, it is still worth confirming with your VCS instructor that you took a full sequence based on the dates that you completed the courses. For instance, sometimes a course has the same names and numbers under both requirements, but the content hours change on a certain date.



### How do I determine my courses' content areas and content hours?

- If you have completed courses in a VCS, meet with your VCS Coordinator to review which content hours are on record for the course with ABAI and, if needed, use the conversion tables to determine how many hours you have under the relevant requirements. Make sure that you are looking at the course's name, number, and the dates when the content hours were taught because when courses change, the content hours might be different and might not meet certain requirements.
- If you have completed behavior-analytic courses that are not in a VCS, meet with your instructor
  and chair to determine whether they will sign a 4th edition or 2022 Nonverified Course
  Content Attestation.

Not sure your coursework qualifies? You can request a <u>preliminary coursework evaluation</u> before submitting a BCaBA Certification Application. We will only evaluate coursework through a preliminary coursework evaluation or certification application.

### **Experience and Fieldwork**

All experience and fieldwork must meet the requirements in place at the time of submitting a certification application.

- ► Trainees who are accruing experience/fieldwork hours and are unsure whether they will apply before or after 2022 or are wanting to use some of the hours toward the BCaBA requirements: We strongly recommend that you meet both sets of requirements to ensure that your hours will count. This includes:
  - meeting all experience and fieldwork requirements (see the following table)
  - completing documentation under both systems (e.g., completing a Monthly **Experience** Verification Form and a Monthly **Fieldwork** Verification Form)
  - maintaining documentation systems for both so that, in the event of an audit, you can demonstrate that you are meeting the relevant requirements (e.g., number of observations, number of contacts)
  - · ensuring that all of your hours that meet the current requirements are accrued within a 5-year time frame

*Note:* Depending on when you apply, submit the forms that correspond with the requirements you are applying under.



If you completed your experience hours under the current experience requirements (i.e., not the fieldwork requirements), you might not be able to count those hours beginning in 2022. This might be the case even if you accrue more hours to meet the overall hour requirements because of differences in the requirements (e.g., number of contacts).

If your experience meets the fieldwork requirements, but you did **not** complete Monthly Fieldwork Verification Forms (M-FVFs), please maintain documentation to support that you met the fieldwork requirements in the event of an audit. Your supervisor may sign a Final Fieldwork Verification Form (F-FVF) if they can agree to all of the attestations on the form (e.g., that all of the hours met the fieldwork requirements). However, make sure you use M-FVFs from that point on, if applicable.

Not sure if you are meeting both the current experience and fieldwork requirements? You can review your documentation system, Monthly and Final Experience and Fieldwork Verification Forms, and this page with your supervisor to ensure that all of the requirements have been met.



## New BCBAs who are supervising trainees:

Beginning January 1, 2022, if you provide supervision to BCBA and BCaBA trainees who are accruing fieldwork hours, you must meet with a consulting supervisor each month in which you provide supervision for the remainder of your first year as a BCBA. For example, if you became certified on June 1, 2021, you would need a consulting supervisor for each month in which you provide supervision to trainees from January 1, 2022, to May 31, 2022.

Please note that this requirement does not apply to the following:

- BCBAs providing supervision to trainees **before** January 1, 2022;
- BCBAs who have been certified as BCBAs for **more than** one year;
- BCBAs in their first year who are **not** providing supervision to trainees accruing fieldwork hours; OR
- BCBAs providing ongoing supervision to **only** RBTs or BCaBAs.

The details of this requirement can be found in the <u>Consulting Supervisor Requirements for New BCBAs</u> Supervising Fieldwork document.

## **Examination**

▶ Candidates whose BCaBA applications were approved before January 1, 2022: Your two-year examination authorization will continue into the introduction of examinations under the BCaBA Task List (5th ed.) on January 1, 2022. Therefore, if you do not pass the certification examination before January 1, 2022, and have remaining attempts, you will be required to take the examination under the 5th edition task list.
